6. External Events & Founding Member Participation

8. Membership & Billing

Membership is \$42/month and renews automatically unless canceled.

Access is contingent upon:

- Active payment
- Compliance with these Guidelines

DMP may suspend or terminate access for violations.

No refunds will be issued for termination due to policy violations.

9. Limitation of Liability

To the fullest extent permitted by law, Digital Marketing Partner LLC and its affiliates shall not be liable for indirect, incidental, consequential, or business losses arising from participation in Lionheart Den.

Total liability shall not exceed the amount paid by you in the 12 months preceding any claim.

10. Governing Law
